





Q2 How often have you participated in Disaster Ready educational opportunities?





Q3 I have participated in Disaster Ready NHICS training.










Q7 My facility would potentially like to host a TTX facilitated by Disaster Ready in the future.







Q9 The emergency preparedness and NHICS training provided by the Disaster Ready program through the years helped my facility adequately respond to the COVID-19 emergency.






